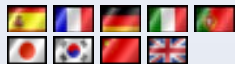

## Manufactured housing group to monitor complaints

LUCERNE – The Manufactured Housing Citizens Group will open its Complaint Monitoring Program to the public on Tuesday, Nov. 13 from 6:30 p.m. to 8:30 p.m. at the Lucerne Fire Hall conference room, 6257 Seventh Ave., Lucerne.

Volunteers will distribute official complaint forms and instruction sheets from the HCD Mobilehome Ombudsman.

Complaints will mailed as a group, and Manufactured Housing Citizens will monitor the agency's response to individuals. If problems are not fixed, the group will publish these findings and seek remedy from other authorities.

The group will similarly monitor filings by Lake County residents with small claims court (limit \$4,000 to \$7,500).
